

**Issue of an access code for the Coolatai Landfill Waste Facility is dependent on the ongoing adherence with the Coolatai Landfill Terms of Use Agreement.**

## **General Conditions**

1. To not share or give out the access code to persons that do not reside at the property.
2. Only disposing of waste from the property nominated in this agreement.
3. Sorting and depositing waste into the designated signed areas at the landfill site
4. No commercial waste.
5. No asbestos (Disposal available at Warialda and Bingara Landfills).
6. No chemical waste (Dispose at Household Chemical collection events at Warialda and Bingara Landfills).
7. No chemical drums (DrumMuster available at Croppa Creek, Warialda and Bingara Landfills. Bookings essential see: <https://www.agsafe.org.au/dm-collection-sites> ).
8. No liquid waste.
9. No petroleum or oil products (Disposal available at Warialda and Bingara Landfills).
10. Placing waste items as far back into the areas as practicable to maximise the available space at the site.
11. No scavenging.
12. Access during daylight hours only.
13. Advising Council of any issues at the Landfill site.
14. Follow directions on signage at the site.
15. Follow directions given by staff on the site.
16. No smoking, naked flames, or lighting fires.
17. I understand that the facility is under CCTV surveillance.
18. Advise Council if you are moving or renting your property.
19. Ensure the chain on the gate is placed back in its original location and the lock is securely closed. The lock will automatically re-engage.

## **Rental Properties**

1. I will inform the council when a tenant leaves, and a new code will be issued.
